A – VISION 2030: FINANCE & INFRASTRUCTURE

FINANCE

1. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the Proposed Budget for Fiscal Year 2020-2021 for submission as follows:

WHEREAS, during the public hearing held on May 5, 2020, the Board of Education discussed the 2020-2021 School District Budget and provided opportunity for public comment at each Board meeting where the Board discussed the 2020-2021 Budget from December 17, 2019 through March 17, 2020; and

WHEREAS, the tentative 2020-2021 School District Budget requires the use of Emergency Reserve Funds for school security improvements in the amount of \$209,443.00; and

WHEREAS, the tentative 2020-2021 School District Budget requires the use of Maintenance Reserve Funds for facility maintenance improvements in the amount of \$177,000.00; and

WHEREAS, the school district policy (Expenses - #9250) and N.J.A.C. 6A:23A-7.3 provides that the Board of Education shall establish in the annual school budget a maximum expenditure for the 2020-2021 school year; and

WHEREAS, that the Sayreville Board of Education hereby establishes the school district travel maximum for the 2020-2021 school year at the sum of \$50,300.00 and be it further resolved that the School Business Administrator shall track and record

these costs to ensure that the maximum is not exceeded. Current 2019-2020 schoolyear expenditures are \$32,171.82 and budget is \$64,001.00; and

WHEREAS, the 2020-2021 Budget Comparison with Justification Reports include the supporting documentation for this 2020-2021 Budget and also contains an itemization of certain expenditures and revenues required under administrative regulations; and

NOW, THEREFORE, BE IT RESOLVED, that the Sayreville Board of Education adopt the Proposed Budget for Fiscal Year 2020-2021 for the School District General Fund Budget of \$95,541,326.00, including a local tax levy \$64,418,966.00; and

NOW, THEREFORE, BE IT RESOLVED, that the Sayreville Board of Education adopt a Proposed Budget for fiscal school year 2020-2021 for the school district special revenue fund budget of \$9,241,928.00; and

NOW, THEREFORE, BE IT RESOLVED, that the Sayreville Board of Education adopt a Proposed Budget for fiscal school year 2020-2021 for the school district debt service fund budget of \$3,617,369.00, including a local tax levy \$3,538,127.00.

2. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the maximum allowable cost for an independent evaluation to be the reasonable and customary rate of \$800.00 per evaluation, for the 2020-2021 school year.

3. The Superintendent recommends and so moves the Board of Education of Sayreville to accept the New Jersey Department of Education approval of the 2020-2021 Preschool Expansion Aid (PEA) Plan and Budget, and the submission of the revised Budget Statement.

4. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the following resolution:

BE IT RESOLVED that the Board of Education herby appoints the following Educational Services ("FIRM") and approves the Agreement for Professional Services between the Board and the Firm (s) for the period of July 1, 2020 through June 30, 2021. The Board shall pay the Firm (s) per the fee structure established, not to exceed as listed below for school year 2020-2021.

• Bayada Home Health Care, Inc. to provide Nursing Services at a rate of \$54.50/hour for RN Services and \$44.50/hour for LPN Services, not to exceed \$280,000.00.

• Center for Behavioral Health to provide Psychiatric Services at a rate of \$525.00 per office visit and \$600.00 per school visit, not to exceed \$21,000.00.

• Cross County Clinical & Education Services, Inc. to provide Various Services per fee schedule, not to exceed \$20,000.00.

• Defined Learning Solutions to provide Educational, Psychological and Social evaluations at a rate of \$350.00 per evaluation, not to exceed \$15,000.00.

• Delta-T Group to provide nursing services during the ESY program, not to exceed \$3,150.00.

• Effective School Solutions to provide Therapeutic Mental Health Services at SWMHS and SMS, not to exceed \$502,000.00.

• Sharon Ferraro, to provide Sign Language Services at a rate of \$200.00 per visit for the first two hours, an additional charge of \$75.00 per hour thereafter, not to exceed \$2,000.00.

• Jem Rehabilitation, LLC to provide Physical Therapy at a rate of \$85.00/hour, not to exceed \$60,000.00.

• Jewish Vocational Services to provide Various Services per fee schedule, not to exceed \$18,000.00

• Maximum Healthcare Nursing Services to provide Nursing Services at a rate of \$56.13/hour for RN Services and \$45.83/hour for LPN Services, not to exceed \$60,000.00.

• Meridian Pediatrics to provide Neurologic Evaluations at a rate of \$175.00 per evaluation, not to exceed \$18,000.00.

• NJ Care for ABA Services and Crisis Prevention Services at a rate of \$120.00/hour, not to exceed \$185,000.00.

• Aida Pereira to provide Bilingual Speech Language Evaluation Services, per fee schedule, not to exceed \$7,500.00.

• Rutgers University Behavioral Healthcare to provide Therapeutic and Crisis Intervention services to Elementary and SUES students, not to exceed \$275,865.00

• Michael J. Simon, MD., F.A.C.P. to provide Professional Services to include Medical Interpretation, feedback and advice pertaining to employee health on an as needed basis, not to exceed \$2,000.00.

• Star Pediatric Home Care Agency to provide Nursing Care at a rate of \$58/hour for RN Services and \$48.00/hour for LPN services, not to exceed \$85,000.00.

• Summit Speech School to provide Itinerant Services, at a rate of \$155.00/hour, not to exceed \$130,000.00.

5. The Superintendent recommends and so moves the Board of Education of Sayreville to approve a temporary transfer of funds from the School Climate Account to the Class of 2020 Trip account in the amount of \$22,000. This transfer will allow for families that contributed to be reimbursed for their out of pocket expenses and will be reversed upon receipt of all refunds/credits.

6. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the acceptance of the Unruly Studios COVID-19 Grant of two STEM floor mats valued at \$500.00 for the Project Before preschool program.

7. The Superintendent recommends and so moves the Board of Education of Sayreville to retroactively approve the expenses for three coaches to accompany the Sayreville War Memorial Varsity Cheerleaders to the Cheer Movement Northeast Cheerleading Competition in Wildwood, NJ. 2. Pursuant to enacted Legislation, P.L. 192-1989, chapter 254, the Sayreville Board of Education is requested to elect John Walsh to the Representative Assembly of the Educational Services Commission of New Jersey at their meeting held on May 5, from June 1, 2020 through May 31, 2021.

3. The Superintendent recommends and so moves the Board of Education of Sayreville to certify that the findings of the ESSA Title I Audit were discussed at the public meeting on April 7 and to approve the corrective action plan which addresses the issues raised in the findings.

4. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the 2020 List of State-Imposed Special Education Rules, Regulations, or Policies in Accordance with 20 U.S.C. §1407(a).

5. The Superintendent recommends and so moves the Board of Education of Sayreville to approve a temporary revision during the time of distance learning to BOE Regulation # R6147.1 Student Assessment, Reporting, and Reporting of Grades. The changes will apply to grades 6-12 grading. The changes are the following:

- The third marking period quarterly is eliminated
- The 15% normally allocated to the third quarterly exam grade is redistributed to other categories depending on individual departments.
- The lowest grade on the report card for the third marking period will be a 60.
- The fourth marking period quarterly is eliminated.
- Classwork/homework will be 20% of the grade and 80% will be other assessments determined by each department in the fourth marking period.
- The third marking period grade is the baseline for the fourth marking period.
- If a student satisfactorily completes work and participates in distance learning, the student's fourth marking period grade will not be lower than the baseline.
- If a student does not satisfactorily complete fourth marking period work, their fourth marking period grade may drop below a 60% in commensuration with their effort.
- If the student's fourth marking period grade is higher than the baseline, the student will earn the higher grade for the fourth marking period.
